## TERMS AND CONDITIONS

Air: EXECUTOURS TRAVEL SERVICE, INC. ("EXECUTOURS") will ticket and make Air Reservations from the most convenient departing cities; and arrange other individual air or land travel needed. ICC's Tour Land Price will be discounted \$75 per person for those whose Round Trip Air from U.S. to Europe are ticketed by EXECUTOURS. Executours and ICC are independent companies not affiliated with or agents for one another. Executours is not the operator of or responsible for any aspect of ICC's Tours. ICC is not responsible for Air arrangements.

Deposit & Payment: Deposit of **\$1,500/person, except \$2,000/person for Munich Ring Tour**, plus **Single Supplement** charge must accompany all Tour Applications. Balance of Tour Land Price is due: **50% by March 15, and Final Balance by April 30, EXCEPT-**

**Hamburg & Berlin—50% by February 4, and Final Balance by March 24.**  
**Vienna & Dresden – 50% by February 24, and Final Balance by April 9.**

ALL LAND PRICE DEPOSITS & PAYMENTS PAID IN CASH (CHECK) TO: INTERNATIONAL CURTAIN CALL (ICC) at the address listed above. Airfare is payable to EXECUTOURS by credit card or cash at least 30 days before departure.

CANCELLATIONS: Cancellations 120 days or more before departure – refund, less administration charge of \$500/person; 119-90 days before departure – refund less 30% of Land Price; 89-45 days before departure—refund less 45% of Land Price; Less than 45 days in advance of departure – entire Price charged unless space resold. Note: Above refund policy does not apply to any Reservation Fee made prior to above Booking Application, none of which is refundable except as per such Reservation's terms. Cancellation of Air may result in forfeiture. Cancellations must be in writing and take effect on receipt. No refunds can be made for tours, meals, sight-seeing, transfers, theater tickets, accommodations or other services included, which for reasons of illness, cancellations or otherwise were not utilized.

Responsibility: INTERNATIONAL CURTAIN CALL & EXECUTOURS and/or its associated companies, principals or agents act only in the capacity of agents for the passengers in all matters of transportation, tour operations and other services. All receipts, tickets, vouchers, coupons or exchange orders are issued subject to the terms and conditions under which transportation and other services are provided;

and ICC, EXECUTOURS, and their associated companies or agents assume no liability for injury, damage, loss, accident, delay or irregularity that may be caused to person or property, either by defect in a vehicle or for any reason whatsoever, or through the acts or default of any company or persons engaged in conveying the passenger or in carrying out the arrangements of the tour. All such losses or expenses will be borne by the passenger as tour rates provide for arrangements only for the time stated. The right is reserved to substitute hotels of similar category, change named guides, change the itinerary where deemed necessary, and to cancel the tour prior to departure, in which case, full refund constitutes full settlement to the passenger. Listed Performances and Casts are subject to change. No refunds shall be made for any change of casts or performances; or performance tickets obtained in other sections of theater if unavailable in Orchestra section. If tickets are unavailable for a performance, refund will be made for ICC's Budgeted cost of same.

Baggage is at owner's risk entirely. The issuance and acceptance of voucher or ticket as well as the signing of the Tour Application shall be deemed to be consent to the above conditions. All arrangements for land accommodations, transportation, sight-seeing and performance tickets are made by ICC, and for Air Transportation by EXECUTOURS, their agents and representatives. The airlines concerned and their agents and affiliates are not responsible for any act, omission, or event during the time passengers are not aboard their aircraft. The services of any IATA carrier may be used for this tour and transportation within the USA may be provided by any member carrier of the Air Traffic Conference of America.

Prices are subject to change for: currency exchange fluctuations (after December 30, 2011); increased costs due to a smaller group than 10; or Performance Tickets required to be purchased from "secondary markets". Quoted Economy Airfare is Airline price quoted December, 2011—Subject to adjustment to price in effect at time of ticketing.

Alternate excursions may be substituted at ICC's discretion if group members so elect, or have been on planned excursions before.
